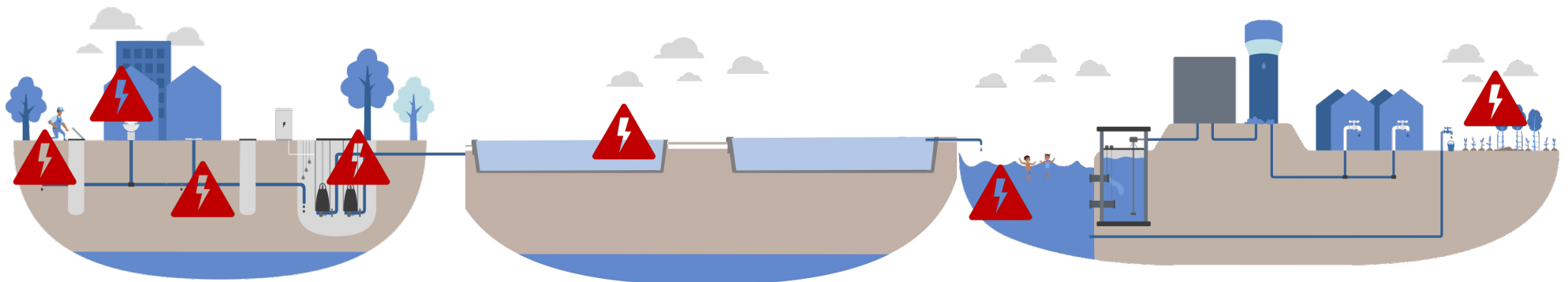


SSP ensures that the system is managed to meet the health objectives

How does SSP work?

Risk assessment and management tool:

- Map and describe the **sanitation system**
- Identify the affected people or **exposure groups** (users, workers, communities, farmers, consumers)
- understand **transmission pathways** of excreta-related infections
- identify what could go wrong (**hazardous events**), evaluate the risk
- prioritize **highest health risk**
- Implement and monitor **control measures** to avoid exposure

Ideas!

- In new and existing sanitation projects to identify investment needs.
- In a municipality which has large % of people not connected to the sewer.
- In urban areas in which the fate of faecal sludge management is un-known.
- In a centralized sanitation systems, where the reuse of treated effluent by farmers is not monitored.
- In areas in which enteric diseases are known.
- In highly populated areas using on-site sanitation.

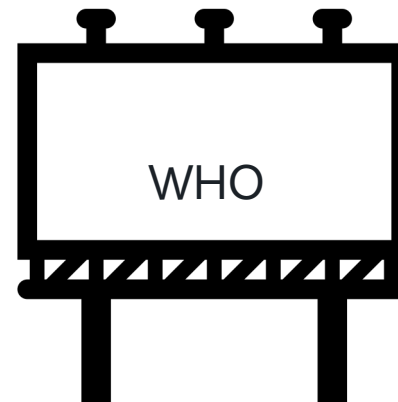
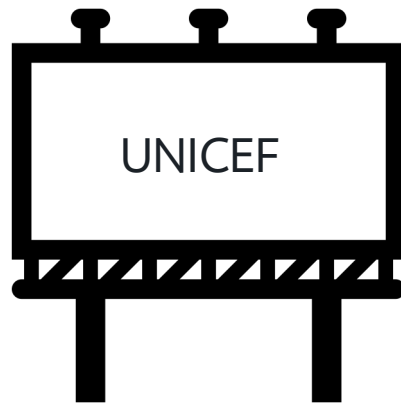
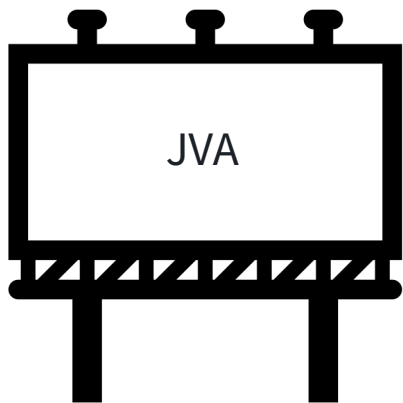
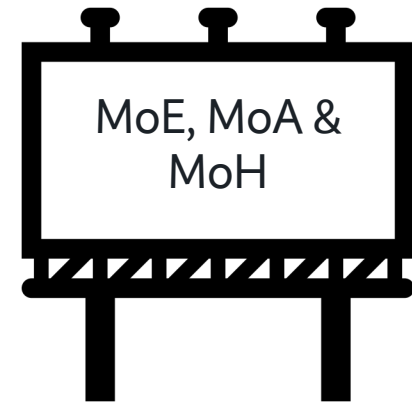


Final Group Exercise

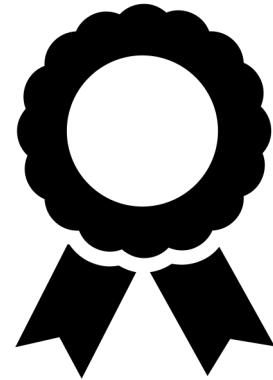
1. Identify a SSP project idea.
2. Decide who is your target audience.
3. Prepare a 5 minutes pitch to engage the target audience.
4. Prepare a flipchart with key information about SSP and benefits for the selected target audience. This will be your stand.
5. Choose 3 speakers: 1 for each round.
6. We will start the marketplace at 11:00am. Each one of you will receive 1 SSP coin. One of your team stays at your booth, and the other goes around the other booths. The one who stays pitches and “engages” other participants. We repeat 3 times.

SSP requires capacities from a range of stakeholders to initiate, develop, implement, monitor and sustain the process to safely manage

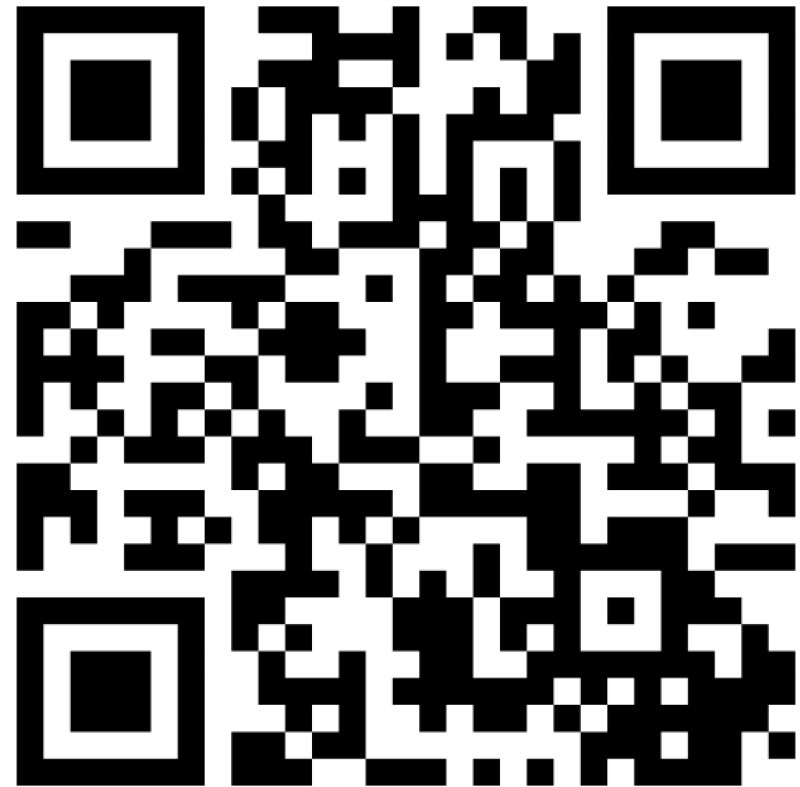
